

NOTICE UNDER SECTION 33 ROAD TRAFFIC ACT, 1961

I, Christopher Drew Holland, Senior Sergeant First Class of Police, for, and on behalf of the Commissioner of Police, exercise the authority delegated by the Minister for Transport under Section 11 Road Traffic Act, and make the following order under Section 33 of the Act.

I declare that the '2025 Adelaide Hills Rally' is an event to which this section applies and that the following roads be closed to traffic between the below listed times and dates:

THURSDAY 02 OCTOBER 2025

Within the the Mount Barker Council area:

Summit Test Track

- Cattle Route Road between Back Callington Road and a point approximately 3km north
- Back Callington Road between Cattle Route Road and Spring Lane
 Between 7.00am and 5.30pm

SATURDAY 04 OCTOBER 2025

<u>Within the Adelaide Hills Council area and / or the Mount Barker Council area and / or Alexandrina Council area:</u>

Retreat Valley Stage

- Retreat Valley Road between Gorge Road and Odea Road
- Odea Road between Retreat Valley Road and Berry Hill Road
- Berry Hill Road between Odea Road and Langley Road
- Langley Road between Berry Hill Road and Cudlee Creek Road Between 7.00am and 12.30pm

- Commercial Road between Mill Street and Albyn Terrace

- Cox Road between Ashbourne Road and Wattle Flat Road
- Wattle Flat Road between Cox Road and Ashbourne Road Between 12.30pm and 6.00pm

- Formby Road between Frith Road and Potter Road Between 7.00am and 1.00pm

- Taverner Road, between Wellington Road and Klenke Road
- Klenke Road, between Taverner Road and Burwood Road
- Burwood Road Road, between Klenke Road and Williams Hill Road
- Williams Hill Road between Burwood Road and Callington Road Between 12.45pm and 6.45pm

Callington Back Stage

- Petwood Road, between Ironstone Range Road and Back Callington Road
- Back Callington Road between Petwood Road and a point approximately 300 metres west of Mine Road

Between 1.15pm and 7.15pm

I direct that competitors and officials taking part in the '2025 Adelaide Hills Rally' be exempted, in relation to a road on which the event is to be held, from the duty to observe any enactment, regulation or by-law prescribing a rule to be observed on roads by drivers of vehicles.

I further direct that the event must comply with the following:

- Comply with all Motorsport Australia requirements
- All closures must be conducted by personnel with the appropriate Work Zone Traffic Management training and utilising approved signage.
- All vehicles participating must be registered and road worthy
- All participants must hold appropriate drivers licence and not be disqualified from driving or form holding a licence in any state.
- Participants are not exempt from RTA offences related to drink and drug driving.

I also hereby authorise the '2025 Adelaide Hills Rally' or its agents and contractors to install and remove, or cause the installation and removal of necessary and appropriate traffic control devices for the conduct of this event.

All works to be undertaken must be done so in accordance with the "SA Standards for Workzone Traffic Management" (which calls up the Austroads Guide to Temporary Traffic Management and AS1742.3).

The permit holder must ensure that, a legible and complete copy of this Approval (as either a hard copy or electronic copy) is available at the event site at all times that workers are present and is immediately provided to an Authorised Officer upon request.
