NOTICE UNDER SECTION 33 ROAD TRAFFIC ACT, 1961

I, Christopher Drew Holland, Acting Senior Sergeant of Police, for, and on behalf of the Commissioner of Police, exercise the authority delegated by the Minister for Transport under Section 11 Road Traffic Act, and make the following order under Section 33 of the Act

I declare that '**Lobethal Christmas Pageant**' is an event to which this section applies and that the following road be closed to traffic **between the listed times on Saturday 9 December 2023**:

Within the Adelaide Hills Council: -

- **Main Street, Lobethal** between Woodside Road and Pioneer Avenue
Between 4.30pm and 9.00pm
- **Woodside Road, Lobethal** between Lobethal Road and Ridge Road
- **Lobethal Road, Lobethal** between Mill Road and Pioneer Avenue
- **Jeffrey Street, Lobethal**
- **Onkaparinga Street, Lobethal**
Between 7.30pm and 8.30pm

I direct that persons taking part in the '**Lobethal Christmas Pageant**' on the above road be exempted from all Australian Road Rules relating to pedestrian behaviour, the carriage of persons in or on vehicles, and seatbelts as long as the vehicles do not exceed 10 km/h.

TEMPORARY TRAFFIC CONTROL DEVICE

NOTICE UNDER SECTION 17 (3) ROAD TRAFFIC ACT, 1961

I further declare that the '**Lobethal Christmas Pageant**' to be conducted at **Lobethal** is a '**temporary purpose**' to which this section applies.

I direct that a **25 km/h** speed restriction will apply to the following roads **between 4.30pm and 10.00pm on Saturday 9 December 2023**:

Within the Adelaide Hills Council: -

- **Pioneer Avenue, Lobethal** from Lobethal Road for 50 metres west
- **Lobethal Road, Lobethal** from Pioneer Avenue to a point 50 metres north of Ridge Road
- **Ridge Road, Lobethal** from Lobethal Road for 50 metres east
- **Mill Road, Lobethal** from Lobethal Road for 50 metres north
- **Ridge Road, Lobethal** for 50 metres either side of Woodside Road
- **Lobethal Road, Lobethal** from Mill Road for 50 metres south.

I also hereby authorise **Fast Lane Traffic Management** or its agents and contractors to install and remove, or cause the installation and removal of necessary and appropriate traffic control devices for the conduct of this event.

I direct that the installation and removal of necessary and appropriate traffic control devices for the conduct of this event can only be performed by a person with work zone traffic management training.

All works to be undertaken must be done so in accordance with the **"SA Standards for Workzone Traffic Management"** (which calls up the **Austroads Guide to Temporary Traffic Management and AS1742.3**).

The permit holder must ensure that, a legible and complete copy of this Approval (as either a hard copy or electronic copy) is available at the event site at all times that workers are present and is immediately provided to an Authorised Officer upon request.
