NOTICE UNDER SECTION 33 ROAD TRAFFIC ACT, 1961

I, Christopher Drew Holland, Senior Sergeant of Police, for, and on behalf of the Commissioner of Police, exercise the authority delegated by the Minister for Transport under Section 11 Road Traffic Act, and make the following order under Section 33 of the Act

I declare that '**Stirling Christmas Pageant**' is an event to which this section applies and that the following roads be closed to traffic **on Sunday 3 December 2023 between stated times below:**

Within the Adelaide Hills Council area: -

- **Mount Barker Road Stirling** between Pomona Road Twin Street
Between 10.00am and 1.00pm
- **Johnston Street, Stirling** between Mount Barker Road and the Stirling Hotel car park driveway.
(Local traffic only)
- **Druid Avenue, Stirling** between Mount barker Road and Milan Terrace
Between 9.00am and midday

I direct that persons taking part in the '**Stirling Christmas Pageant**' on the above road be exempted from all Australian Road Rules relating to pedestrian behaviour, the carriage of persons in or on vehicles, and seatbelts as long as the vehicles do not exceed 10 km/h.

TEMPORARY TRAFFIC CONTROL DEVICE NOTICE UNDER SECTION 17 (3) ROAD TRAFFIC ACT, 1961

I further declare that the '**Stirling Christmas Pageant**' to be conducted at **Stirling** is a '**temporary purpose**' to which this section applies.

I direct that a **40 km/h** speed restriction will apply to the following roads between **8.00am and 2.00pm on Sunday 3 December 2023:**

Within the Adelaide Hills Council area: -

- **Avenue Road, Stirling** between from Mount Barker Road for 50 metres west
- **Pomona Road, Stirling** between from Mount Barker Road for 50 metres east
- **Mount Barker Road, Stirling** from Pomona Road for 50 metres north
- **Milan Terrace, Stirling** for 50 metres either side of Druid Avenue
- **Stonehenge Avenue, Stirling** from Milan Terrace for 50 metres west
- **Gould Road, Stirling** between from Mount Barker Road for 50 metres north
- **Twin Street, Stirling** between from Mount Barker Road for 50 metres south
- **Mount Barker Road, Stirling** from Twin Street for 100 metres east.

I also hereby authorise **FastLane Traffic Management** or its agents and contractors to install and remove, or cause the installation and removal of necessary and appropriate traffic control devices for the conduct of this event.

I direct that the installation and removal of necessary and appropriate traffic control devices for the conduct of this event can only be performed by a person with work zone traffic management training.

All works to be undertaken must be done so in accordance with the **"SA Standards for Workzone Traffic Management"** (which calls up the **Austroads Guide to Temporary Traffic Management and AS1742.3**).

The permit holder must ensure that, a legible and complete copy of this Approval (as either a hard copy or electronic copy) is available at the event site at all times that workers are present and is immediately provided to an Authorised Officer upon request.
