NOTICE UNDER SECTION 33 ROAD TRAFFIC ACT, 1961

I, Christopher Drew Holland, Senior Sergeant of Police, for, and on behalf of the Commissioner of Police, exercise the authority delegated by the Minister for Transport under Section 11 Road Traffic Act, and make the following order under Section 33 of the Act

I declare that **'Woodside Christmas Pageant'** is an event to which this section applies and that the following road be closed to traffic **between 6.30pm and 9.30pm on Thursday 14 December 2023:**

Within the Adelaide Hills Council: -

- **Onkaparinga Valley Road, Woodside** between St Marks Drive and Nairne Road
- **Station Road, Woodside** between Langbein Avenue and Onkaparinga Valley Road
- **Langbein Avenue, Woodside** between Station Road and Onkaparinga Valley Road
- **Nairne Road, Woodside** between Onkaparinga Valley Road and Robert Street.
- **Moffett Street, Woodside** between Onkaparinga Valley Road and a point approximately 90 metres east.

I direct that persons taking part in the **'Woodside Christmas Pageant'** on the above road be exempted from all Australian Road Rules relating to pedestrian behaviour, the carriage of persons in or on vehicles, and seatbelts as long as the vehicles do not exceed 10 km/h.

TEMPORARY TRAFFIC CONTROL DEVICE NOTICE UNDER SECTION 17 (3) ROAD TRAFFIC ACT, 1961

I further declare that the **'Woodside Christmas Pageant'** to be conducted at Lobethal is a **'temporary purpose'** to which this section applies.

I direct that a **temporary speed restriction** will apply to the following roads **between 6.30pm and 9.30pm on Thursday 14 December 2023:**

Within the Adelaide Hills Council: -

25km/h speed restriction

- **Onkaparinga Valley Road, Woodside** between View Road and the event road closure near St Marks Drive
- **Jacaranda Drive, Woodside** from Onkaparinga Valley Road for 50 metres east
- **Robert Street, Woodside** from Nairne Road for 50 metres north
- **Nairne Road, Woodside** from Robert Street for 50 metres east

40km/h speed restriction

- **Onkaparinga Valley Road, Woodside** from Riverview Road for 100 metres south
- **Riverview Road, Woodside** between Onkaparinga Valley Road and Nairne Road
- **Pfeiffer Road, Woodside** from Nairne Road for 100 metres north-east

- **Nairne Road, Woodside** for 100 metres either side of Pfeiffer Road.

I also hereby authorise **Fast Lane Traffic Management** or its agents and contractors to install and remove, or cause the installation and removal of necessary and appropriate traffic control devices for the conduct of this event.

I direct that the installation and removal of necessary and appropriate traffic control devices for the conduct of this event can only be performed by a person with work zone traffic management training.

All works to be undertaken must be done so in accordance with the **"SA Standards for Workzone Traffic Management"** (which calls up the **Austroads Guide to Temporary Traffic Management and AS1742.3**).

The permit holder must ensure that, a legible and complete copy of this Approval (as either a hard copy or electronic copy) is available at the event site at all times that workers are present and is immediately provided to an Authorised Officer upon request.
