Enrolling to vote

The voters roll for the 2025 Adelaide Hills Council Valleys and Ranges Ward Supplementary Election closes at 5pm on Monday 30 June 2025.

If you are already on the state electoral roll (in your council area) and vote in state elections, you are automatically included on the council voters roll.

Voting in the Supplementary Election

All voting in council elections is by postal ballot.

Enrolled voters will receive a voting package directly through the mail including ballot paper and a reply-paid envelope.

Ballot papers will be delivered to the enrolled address from Tuesday 26 August until Monday 1 September 2025.

Your ballot papers must be completed and received by the Electoral Commission of SA by 12:00 pm, Monday 22 September 2025.

Most people on the Council voters roll are eligible to stand for election, provided they meet the nomination requirements.


You do not need to live in or own property within the ward you choose to nominate for.

Serving as a councillor is a meaningful way to shape local decisions and help create longterm, positive outcomes for the community.

We strongly encourage nominations from people of diverse backgrounds to ensure a broad range of perspectives are represented in Council.

With few exceptions, (such as being an undischarged bankrupt or being disqualified by a court order) anyone can nominate for Council regardless of qualifications, religion, race, gender, experience, or profession.
