"A commitment to deliver on such priorities now, provides the greatest opportunity to enhance the social, economic and environmental prosperity for our local community, our state and our nation."





State and/or Federal Priorities for AHC and the region 2021-22 (as at 11 April 2022)


	Project/Action	Location	Description	Cost Estimate
1	Passenger and Freight <u>Transport</u> : support State Govt in its commitment to the actions outlined in the Infrastructure SA report	District and Region	 Fast commuter passenger transit between Mt Barker/Strathalbyn and the Adelaide CBD. Improve public transport in the Hills in the shorter term through rapid bus transit along the South-eastern Freeway and establish new and expanded park and rides (consistent with the recent Infrastructure SA Mount Barker Mass Transit Study outcomes). Further to the above, expand the park and ride at Crafers thereby overcoming associated commuter parking problems. Northern Freight Train Bypass to improve the efficiency of freight movement and connect with the national rail network - and potentially free up existing rail corridor for longer term commuter passenger transit options (see above). Continue to support safer and better trafficable roads through Black Spot; Special Local Roads; and Supplementary Local Roads funding. 	\$200 - \$500m (to be confirmed) \$4.5 - \$6b (to be confirmed)





2	Health: commit to improving GP, ambulance and hospital services in the region	District and Region	 Attracting and retaining GPs in Gumeracha. Following a resolution of Council in October 2021, our Mayor has written to the Hon the Premier requesting that the South Australian Government takes all actions possible (and advises Council and its community precisely what those actions will be) to ensure that rural and regional communities can attract and retain doctors and other health professionals. Re-open Gumeracha Hospital Emergency Department (that was closed due to COVID-19). Expand and enhance the ambulance service throughout the district and region. In particular, allocate additional ambulance crews based in the Adelaide Hills: Aldgate, Mt Barker and Woodside. 	
3	Federal Assistance Grants (FAGs): review the SA FAGs formula to make it more equitable and increase the total Commonwealth funding for these grants	State-wide	Adelaide Hills Council is very grateful for this annual funding which enhances our ability to provide much needed services to our communities, spread over almost 800km2 and over 50 separate townships and urban areas. As communicated with the SA Grants Commission over the past 3 years, we (as a member of the Southern & Hills Local Government Association) respectfully request a review of the FAGs formula as it applies to SA and would welcome an overall increase in this funding by the Commonwealth Government.	



4	Mobile phone blackspots and NBN coverage: lobby Federal Government for increased funding	Various	 To prioritise overcoming mobile phone black spots and enhancing NBN coverage in remote and high bushfire danger areas of the Hills. To prioritise the issue of mobile phone availability during emergencies. In particular, the significant issue of mobile towers failing about 4 hours after mains power is due to insufficient battery powered back-up. 	
5	The Great Australian Wine Trail: invest in this initiative for tourism infrastructure	Region	A joint council and RDA initiative in the region with Barossa Council taking the lead on this proposed project. (Flyer attached).	Still to be costed
6	Bushfire mitigation and response: improve fire-fighting co- ordination and resourcing (including aerial capability)	State-wide	Adelaide Hills Council acknowledges and welcomes the more recent announcements (following the Black Summer Bushfires) of greater collaboration between State and Federal Governments regarding improved co-ordination of efforts in this regard. In particular, we recognise the benefits (as a district with one of the highest bushfire risks in the country) of improved fire-fighting resourcing, including the ability of fire-fighting services across the country to have easy and timely access to aerial fire-fighting capability.

7	Project Disaster Funding <u>Arrangements:</u> make equitable the application of mechanisms for this LG funding	Location State-wide	Overcome the shortcomings for SA councils in the Local Government Disaster Recovery Assistance Arrangements, including eligibility thresholds and criteria, processes to be followed and the quantum of cost recovery available. These mechanisms are inconsistently applied across the country and SA councils are disadvantaged as a result. Adelaide Hills Council notes and supports the following resolution made at the LGASA Ordinary General Meeting held on 8 April 2022: That the Ordinary General Meeting requests that the LGA advocates that the State Government undertakes an urgent review of the Local Government Disaster Recovery Assistance Arrangements (LGDRRA) with a focus on: 1. Making the LGDRAA simpler and more definitive in terms of the support that will be provided to councils in the event of a natural disaster; 2. Significantly reducing the current thresholds for cost reimbursement to levels consistent with other State jurisdictions; 3. Ensuring that the significant internal costs borne by councils during and after a natural disaster are acknowledged and can be recovered in	Cost Estimate

This stage also links to the proposed Great Australian Wine Trail (see above) – once Stage 4 of the project has been completed.	Still to be fully costed
9	Commonwealth Home Support Program: increase federal funding to support desired independent living outcomes		Increase federal funding for the Commonwealth Home Support Program to enable more and adequate services to be provided to those who need them most and reduce existing waiting lists. 10	<u>Croft Road</u> : upgrade and seal this road to promote this regional tourism and recreational facility	Lenswood	To upgrade and seal part (1.7km) of Croft Road as Forestry SA upgrades the Fox Creek Bike Park in Cudlee Creek Forest. The existing road is unsealed and runs through the middle of orchards and vineyards. With the expected increase in traffic, the maintenance burden on the road will increase, as will the dust nuisance. Some minor widening, drainage improvements and sealing will ensure safe and environmentally sound access to the Bike Park.	\$960k
