SUMMARY

The purpose of this report is to obtain a decision on bringing forward a budget allocation of \$100,000 currently outlined in the Long Term Financial Plan in 2020/2021 to 2019/2020, for the Residents Win Gumeracha Main Street project. In addition, the decision to endorse the receipt of \$120,000 from the Department of Planning, Transport and Infrastructure (DPTI) this financial year 2017/2018 to be used for the Residents Win Gumeracha Main Street Stage 2 works within 18 months.

Community:	Whilst no consultation has occurred during the development of this report due to the time criticality, and recent notification, there has been extensive consultation already undertaken by the Gumeracha Main Street Project Group (GMSPG) and the Residents Win Stage 1 Design Framework was released for general community consultation in October 2017.

2. BACKGROUND AND ANALYSIS

In mid-2016 the community-led Gumeracha Main Street Project Group (GMSPG) was formed. This followed a series of community and business meetings and a visioning session, as well as numerous contacts and meetings with relevant Adelaide Hills Council (AHC) staff. The Group's main objective is to improve the amenity, functionality and business prosperity of the Main Street (formally known as Albert Street) in Gumeracha. In March 2017 GMSPG and AHC applied for a Residents Win Grant through the Department of Planning, Transport and Infrastructure (DPTI) which is targeted towards 'creating people friendly streets and safer roads'. This process involved matching the project with a relevant consultant to prepare a concept plan and information to enable the application to be prepared.

GMSPG were matched with Jensen PLUS who prepared a Design Framework for the Main Street. This Design Framework was used as the basis for a Residents Win Stage 1 grant application which resulted in a grant of \$32,500 (exclusive of GST) being offered from DPTI in March 2018. AHC provided a contribution of \$22,500 (exclusive of GST) for this project resulting in \$55,000 being available for Stage 1 of the project.

Stage 1 includes detailed design and documentation of three crossing points and design and installation of 'Quick Wins' including signage, seating, landscaping and/or parklets. In the Stage 1 application process key tasks to be undertaken and an associated budget estimate was also prepared for Stage 2.

GMSPG, AHC and DPTI are now seeking to engage a consultant for Stage 1 to prepare the detailed design and documentation of three crossing points along with design and project management of 'Quick Win' streetscape elements for Gumeracha Main Street (Albert Street) in line with the DPTI Residents Win Stage 1 community grant. The Request for Proposal closed on Monday 4 June and an evaluation process is currently being undertaken.

On Wednesday 6 June 2018 Council received an email from the Residents Win Coordinator for DPTI. The email stated that DPTI have not spent all the available funding for the 2017/2018 year and it was asked if Council was still able to contribute \$90,000 in the 2018/2019 financial year toward the project as originally outlined in the Stage 1 application (information below).

Council has allocated \$100,000 for the 2020/21 financial year within the Long Term Financial Plan Capital Allocation for the Gumeracha Main Street.

DPTI has been able to change their standard 12 month project term to an 18 month term which would have Stage 2 due for completion around December 2019. Therefore if Council is able to bring forward the 2020/21 capital allocation of \$100,000 to 2019/20 the timing along with the PLEC scheme will provide an integrated design response for the Main Street Gumeracha, should the PLEC scheme be prioritised by Council and subsequently approved by PLEC and SA Power Networks.

However due to End of Financial Year budget requirements DPTI need to make the payment this financial year and Council is required to inform DPTI by 14 June 2018 to secure the funding. At this stage there is unfortunately no guaranteed funding from Residents Win beyond 17/18.

- I. Support the movement of the \$100,000 allocation in the 2020-21 Long Term Financial Plan Capital Allocation to 2019-20 to enable the receipt of 120,000 grants funding to be received this current financial year 2017-18 as a contribution towards the Stage 2 works in Gumeracha.
- II. Not support the movement of the related project allocation.
