## **Infrastructure & Operations**

### **Bridgewater Oval Stormwater System Upgrade**

The stormwater system upgrade works at the Bridgewater Oval around the clubroom have now been completed.

Work involved installing 600mm diameter piping to cover the open swale running behind the clubroom and installed grated pits to capture all overland stormwater flows around the clubroom, discharging to Cox Creek. New pipes made of 100% recycled plastics installed to formalise previous swale / creek alignment to prevent flooding of Bridgewater Oval changeroom.

Flood mitigation with historical flooding/inundation of the clubroom at a major rain event has now been addressed.















#### **Grevillea Way, Woodside**

Stormwater detention basin construction work is now in progress at Grevillea Way, Woodside.

In order to address the stormwater flooding issues, nuisance experiencing on a number of properties along Grevillea Way, by controlling the stormwater flows on to Grevillea Way from the upper catchment\detention basin.

Works involved installing an earth dam of approximately 190m length, 1.5m high including associated concrete structures at the back of the properties along Grevillea Way.





Recent changes to Councils directional signage policy has seen the old green sign on green post format replaced by the new Black on White format with Council Logo. Quick response crews have been out and about updating Directional Street Signs and they are looking great.







#### **Street sweeping program**

At this time of year there is a lot of leave and bark drop that prevents good road drainage and looks unsightly. Aside to our Street sweeping program undertaken by Envirosweep that occurs on kerbs roads, Council crews also attend roads without kerb to remove debris.










#### **Maintenance Road Grading**

#### **Completion of Amy Gillett Pathway Bushfire Recovery Project**

There were two elements to the grant.

#### **Promotion of the Amy Gillett Pathway**

Adelaide Hills Tourism have had a page on their website dedicated to the Amy Gillett Pathway for over twelve months. This has included numerous postings about the Pathway on their Facebook and Instagram pages. Search for Cycling the Amy Gillett Pathway | Adelaide Hills Tourism (visitadelaidehills.com.au)

In collaboration with a local graphic designer and a consultant we have developed a Master Plan for the Pathway and a tourist map. The map was developed in consultation with Tourist businesses along the pathway (Melbas, Barristers Block, Woodside Bike About, Lobethal Rd Wines) and the map is now available from these businesses as well as at the Woodside and Stirling Libraries.

#### Signage and Pathway activation

Council's Civil team completed the process of installing signs along the pathway that explain who Amy Gillett was and direct visitors to local tourism businesses and nearby towns. Council has also installed decals along the pathway informing users to keep to the left.

Council has also activated the start of the pathway at Gilman Rd by installing seating which will go in over the next couple of weeks, rubbish bins, a drinking fountain and a bike repair station. Council has also installed a bike repair station at Charlestown and will put in seating at a scenic site on the bikeway just out of the town.















#### **Home Based Business Networking Breakfast**

Council hosted a very successful Home Based Business Networking Breakfast on Thursday 23 June. The event was fully booked out with 28 attendees comprising small Home Based Business Owners and some representatives of service providers including NBN, RDA and the State Government's Small Business Unit. The networking event included a presentation from one of the business owners who shared some of their experience in running a small business. Many of the participants have reported that they found the event very valuable with useful advice from the presentation and they had made good contacts with other businesses. We plan to hold the next event in October this year.

#### 3) Further Information on Display

Also on display at the Council Customer Service Centre and the SA Planning Portal at <a href="https://www.saplanningportal.sa.gov.au">www.saplanningportal.sa.gov.au</a> are the guidelines set by the State Planning Commission for the preparation of a development report for the Redevelopment of the Mount Lofty Golf Estate at Golflinks Road, Stirling. The development, to be assessed by the State Commission Assessment Panel, includes construction of multi-storey tourist accommodation, a new clubhouse, administration, underground car parking, separate tourist villas and redevelopment of the local heritage listed former perfumery building as a café/function area.

The opportunity for members of the community to make submissions on the redevelopment will occur at a future date when the development report, plans and application information are placed on public consultation by the State Planning Commission.

#### **Regulatory Services**

#### **Burning Permits**

Council's Regulatory Services team continues to issue burning permits to property owners within the Adelaide Hills Council area. To date, the Regulatory Services team has issued 154 burning permits and refused 1.

#### **Dog & Cat Management**

The Regulatory Services team continues to enforce the new Cat By-law, which requires that all cats be confined to the property of their owners. Whilst registrations continue to increase within the Council area, Cat related CRM requests are up to 147, with an additional 5 cats having been impounded bringing the total number to 25.

Three expiations have been issued to cat owners for cats wandering onto other people's properties.

With effect from 1 July 2022, a registration fee will apply to all cats within the Adelaide Hills Council area as follows:
