SUMMARY

The South Australian Government Premier and Cabinet Ministers will be attending the Adelaide Hills area on Wednesday 23 August and Thursday 24 August 2023 as part of the Country Cabinet program. Our current understanding is that the community forum will be located in Mt Barker on Wednesday, while more formal Cabinet proceedings will be in the Adelaide Hills on Thursday.

Country Cabinet visits are an opportunity for members of the community, the Premier and government to discuss the challenges and opportunities unique to our region. As such the Mayor and Chief Executive Officer have been invited to present to Cabinet during the Cabinet meeting. Councils' approval is therefore being sought to accept the opportunity to present to Country Cabinet.

In anticipation of your approval a collation of some of the key issues for the region has been prepared for Council consideration. See *Appendix 1*.

1. BACKGROUND

Council has recently been advised that the Premier and Cabinet Ministers will be visiting the Adelaide Hills for their next Country Cabinet on Wednesday 23 and Thursday 24 August. The Premier and Ministers will spend time within the region visiting local residents, business and organisations to discuss the challenges and opportunities unique to the region.

On Wednesday 23 August from 5pm the Premier will host a community BBQ and forum at the Mount Barker High School where members of the public will be welcome to attend. Active promotion of this opportunity will commence the week beginning 7 August 2023.

The Mayor and Chief Executive Officer of both Adelaide Hills Council and Mount Barker District Council have been invited to jointly present to the Strategic Cabinet Meeting on Thursday 24 August at the Onkaparinga Valley Football Club. This will comprise of 20 minutes for the joint presentation, followed by Q&A to give the Premier and Cabinet Ministers the opportunity to further understand what has been presented.

In preparation for this presentation, a summary of some of the key issues for the Adelaide Hills area has been collated for Council consideration and included in *Appendix 1*. While ongoing infrastructure improvements are critical to our region's future prosperity, ensuring regulation and policy are appropriate to deliver the social and economic priorities for our region is also important. As such the areas for consideration have been collated into the following areas:

- Infrastructure
- Policy
- Key Projects

Given the short timeframe available, it is considered that only two or three key priorities will be able to be presented. Council's input into what those key priorities are will be further explored at the next available workshop.

Once Council provides approval for the Mayor and CEO to present at Country Cabinet and confirms the key issues of focus, administration will prepare a presentation to Country Cabinet on each of the key issues, the sought outcome/action requested from the government and any relevant reference documents, reports etc. to provide greater context and clarity.

A copy of a PowerPoint presentation is required by 17 August ahead of the meeting date and to provide some pre-reading for the Premier.


